Safe, Affordable Housing for Seniors

The Senior Housing Assistance Fund was established by the Fairfield County Community Foundation and sponsored by the John H. & Ethel G. Noble Trust. The Southwestern CT Agency on Aging administers the **Senior Housing Assistance Fund (SHAF)** in the following towns:

Bridgeport, Darien, Easton, Fairfield, Greenwich, Monroe, New Canaan,

Norwalk, Stamford, Stratford, Trumbull, Weston, Westport, & Wilton

Interest-free loans are available to income eligible individuals who are 60+ or have a disability for the purpose of securing and remaining in safe, affordable housing. The borrower determines the repayment schedule.

What is it?

The **Senior Housing Assistance Fund (SHAF)** was established by the Fairfield County Community Foundation and sponsored by the John H. & Ethel G. Noble Trust to help income eligible individuals who are at least 60 years of age or have a disability to remain in safe, affordable housing. **SHAF** provides financial assistance in the form of interest-free loans. The funds can be used for security deposits, utility deposits, moving expenses, furnaces, roof repairs, adaptive equipment, and renovations.

Am I Eligible?

An applicant must...

- Be at least 60 years of age OR be 18 years of age or older with a disability.
- Have a household income at or below 200% of the Federal Poverty Level. Annual income at or below:
 - \$27,180/single
 - \$36,624/couple
- Must show the need for funds
- Must live in Bridgeport, Darien, Easton, Fairfield, Greenwich, Monroe, New Canaan, Norwalk, Stamford, Stratford, Trumbull, Weston, Westport or Wilton
