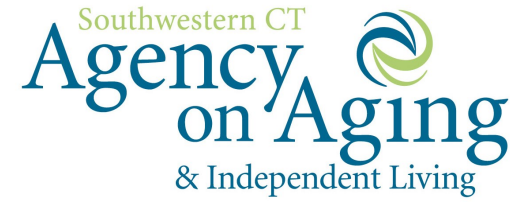

The Southwestern CT Agency on Aging (SWCAA), administers the Connecticut Home Care Program for Elders (CHCPE) in contract with the Connecticut Department of Social Services (DSS) for southwestern CT.

What is CHCPE?

CHCPE provides an alternative to nursing home placement for individuals who meet financial and functional eligibility criteria. In-home services are established to help an elder remain at home with maximum independence.

How can CHCPE help?

A qualified care manager will perform an assessment of a person's functional and financial needs to determine eligibility. Assessments are completed free of charge. The decision to participate in the Program belongs solely to the individual. The individual, family and Care Manager shall discuss desired goals and potential service interventions. A care plan will address personal care, supported independence and safety goals of the person. Personal and cultural preferences will always be honored. Once eligibility is determined and a care plan is authorized, services will begin to help the individual remain at home.

CHCPE can be a tremendous help to you and family caregivers, assisting individuals at risk of Nursing Home placement who would prefer to stay in their home. In most cases, CHCPE can provide a senior the support they need to remain home at no cost to the individual or caregivers.



Who Pays for CHCPE?

CHCPE is a mandatory Medicaid program. If your income and assets qualify, you will be asked to enroll in Medicaid. If you do not qualify for Medicaid, you may qualify for the State-funded Program. Please see the eligibility portion of this flyer for specific details.

How Does an Elder Qualify for CHCPE?

Eligibility can be complicated. The information on eligibility provided in this brochure presents the guidelines. Individuals may benefit from consultation with an Elder Law attorney.

How does One Apply for CHCPE?
