

Where \$ Comes From


FY2022 Total Revenue

Care Management

The Connecticut Home Care Program for Elders serves over 2,500 older adults in southwestern CT. For Mrs. K, the program has special meaning and helps her live independently. Mrs. K began the program over a decade ago after experiencing a stroke. She is seen here with her Care Manager, Christopher. She calls Christopher a gift. This year, when she found herself alone on Thanksgiving, Mrs. K received an invitation to join her long-time aide for dinner with his family.





Grants

The place where everybody knows your name- Hall Neighborhood House. With funding support from the Southwestern Connecticut Agency on Aging, Hall Neighborhood House is home to over 100 seniors. Friendship, fellowship, access to information and services makes Hall a special place. According to Cheryl Delaney, Hall's Executive Assistant, "SWCAA's impact on Hall Senior Center is huge! The support allows us to be there for our Senior Community every day. SWCAA provides learning resources on health and nutrition and information on outside resources that enhance the lives of our seniors. SWCAA supports community caregivers, which in turn benefits our seniors."

Community Services

In August of 2022, the Critical Needs Fund, a specialized charitable fund supported by the Fairfield County Community Foundation and SWCAA donors, met Mrs. J. She had suffered a fall while climbing the front steps of her home. Thanks to the flexible model of the Critical Needs Fund, Service Navigator Olivia was able to purchase and install new handrails. This gave Mrs. J the freedom to once again leave her home. "I am so grateful and thankful of the help this gives me. I now feel safe and have security going up and down the front steps. We're all human and we all need help from one another, Olivia showed me help is still out there."





Community Options

"There is no place like home." It's a feeling expressed by many of SWCAA's participants in the Money Follows The Person Program. Money Follows The Person helps older adults and persons with disabilities transition out of nursing facilities and return to a home in the community. "This program has given me back my freedom," said Mrs. T, seen here with Supervisor Herby as she starts her new life in the community. Mrs. T was wheelchair-bound in the nursing home. Less than five months later, thanks to physical therapy and the support of her SWCAA team, Mrs. T can take steps and ambulate on her own. She invited Herby back to see her improvement-congratulations Mrs. T!
